C - FESTIVAL PARTICIPATION

Choral Events offers choirs participating in the competition the opportunity to also participate in the **International Choral Festival in Provence**, within the limits of available concerts.

Possible dates:

Sunday July 7 & Monday July 8, 2024.

The concerts are organized live by Choral Events or in partnership with its network of municipalities or amateur choirs in the region. The participating groups perform alone or in groups depending on the location or type of concert.

Concert venues can be of several types: Church, concert hall, multi-purpose rooms, exteriors, etc.

Included in the organization of concerts: Reservation of the venue, organization, advertising, group dinner.

Concerts can be shared with local or international choirs depending on availability. The standard duration of a concert is 80 minutes; if several choirs participate, the choirs will be asked to adapt the duration of their performance so that each choir can sing, one after the other, while respecting the overall duration of the concert.

The **detailed repertoire** (title, composer or arranger, duration) must be provided **before April 15, 2024**, as well as a **technical specifications sheet** (number of singers, list of instruments, stage positions, etc.), so that our technical staff can prepare the necessary material, particularly if the concert is fitted with a sound system.

Transportation costs are the responsibility of the choir.

Dinners are organized by Choral Events or by the partner city. They are charged at €25 per person per dinner.

COPYRIGHT AND PERSONAL DATA

When signing the duly completed competition registration form,
the choir and its members:

1. Certify that the choir entering in the competition is a choir composed solely of amateur singers in accordance with the regulations.
2. Commit to not compete with illegal reproductions of scores and to respect the French laws about copyrights.
3. Accept photos taken with their image during the competition, their fixation, their multiple use, their processing and their reproduction, by any means whatsoever, for promotional and/or archival purposes for Choral Events, without limitation of duration or financial compensation.
4. Grant free of charge to the organizers of the competition the right to use the artistic audiovisual recordings made during the competition or the finalists' concert for commercial purposes, in particular promotional and archival purposes, in the following areas of use:
 - a. with regard to fixation and reproduction - recording by means of digital technology of sound and images, their production and their distribution on CDs and/or DVDs or other media;
 - b. with regard to the trade in copies on which an artistic representation has been fixed - placing on the market, lending or leasing copies of such copies;
 - c. with respect to the broadcasting of performances in a manner other than as specified below: broadcasting, rebroadcasting and interpretation and making the performance available to the public on selected web pages.
5. Accept the processing of their personal data for purposes related to the Competition, in accordance with the declaration made in the registration form. Personal data is provided by a participant on a voluntary basis, but its submission is required for participation in the competition.
